The Firefighters Charity Fund Melbourne makes significant donations annually to key Victorian charities in the area of Children's health, Burns Care and Cancer cure and treatment.

These charitable areas reflect a traditional affinity with fundraising conducted in the MFB.

In addition, one charity is selected for support each year from nominations received from contributors. This fund also aims to support many of the other fundraising efforts already being conducted by MFB staff to encourage those already working hard for charities.

FireLegacy is designed to directly assist our community members and their families with the costs of medical treatment due to serious illness or disability.

These applications for help are governed by strict confidentiality and the recipient would need to be nominated by a contributor to the fund.

FAQ's

Will my contributions allow me a tax deduction?

All donations are tax deductible, those donating from their payroll, through workplace giving scheme (deductions pre tax), will have their contributions detailed their group certificate to claim at tax time. A receipt will be sent out for any one off donations.

Where does the money donated to Firefighters Charity Fund Melbourne go?

Firefighters Charity Fund Melbourne donates money predominantly to three core charities each year (children's health, burns care and cancer care or research). The recipients will vary yearly. Money is also allocated to support other charity fundraising

activities conducted within the MFB community and to FireLegacy. On average, 70% of donations will go to the Firefighter's Charity Fund Melbourne, while the remaining 30% will be allocated to FireLegacy.

Who will contribute to the charity?

Both employees of the MFB and members of the public will contribute to the charity. MFB employees are contributing by

weekly payroll deductions voluntarily.

What percentage of my donation goes directly to charity?

100% goes directly to our charitable causes, thanks to sponsorship and volunteers. If you would be interested in sponsoring the charity please use the contact details below.
